## For ACHE Face-to-Face Education Credits New Governmental Focuses on Fraud and Abuse Enforcement

Length:	1.5 hours
Target Audience:	Mid-Careerists to Senior Executives; C-Suite Executives; Clinical Leaders
Description:	In recent years, the U. S. Government has increased its focus on reducing fraud, waste and abuse in the health care system. New legislation and programs have enhanced the government's health care fraud enforcement abilities as well as increased the responsibilities hospitals have to be compliant with the myriad of health care laws, regulations and rules. As a result, hospitals can expect an increase in recoupment of overpayments, audits, and fraud and abuse investigations and litigations. The panelists will discuss the new healthcare fraud and abuse landscape and present strategies to help hospitals be compliant and vigilant in the ever-change healthcare arena.
Faculty:	Moderator plus two to three panelists. We recommend that the moderator have direct experience working in the healthcare sector; expertise in a range of settings will be useful. Because this topic covers both clinical and administrative arenas, the moderator could be a physician, senior leader, and/or a faculty member at an educational institution.
	The panelists will most likely consist of legal advisors (outside attorneys/hospital legal team members) who have experience and understanding in dealing with fraud and abuse legislation and enforcement. Additionally, a panel member could also be a senior-level executive involved with an organization that has had direct involvement with interpreting and implementing these types of rules and regulations (i.e. a Chief Compliance Officer).
